AN ORDINANCE DESIGNATING MEETING DATES AND TIMES AND HOLIDAY OBSERVATIONS IN 2020 FOR THE CORPORATE AUTHORITIES AND PLAN COMMISSION FOR THE CITY OF BRAIDWOOD

WHEREAS, the City of Braidwood (the “City”) is a municipality in accordance with the Constitution of the State of Illinois of 1970; and

WHEREAS, Section 4-5-12 of the Illinois Municipal Code (65 ILCS 5/4-5-12) states that City Council shall provide by ordinance for the holding of regular meetings;

WHEREAS, the City finds and determines it is therefore necessary for the Mayor and the City Council to set dates and times of the regular meetings of the Corporate Authorities in 2020.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BRAIDWOOD, WILL AND GRUNDY COUNTIES, ILLINOIS AS FOLLOWS:

SECTION 1. MEETINGS SET

That City Council and Plan Commission for the City of Braidwood shall meet at the following dates and times and the following Holidays shall be observed on the specified dates:

1. The regular meeting of the Mayor and the City Council of the City of Braidwood in 2020 shall be held at Braidwood City Hall, 141 W. Main Street, Braidwood, IL 60408 on the second and fourth Tuesday of the month at 7:00 pm, unless otherwise designated to a different location, date, or time.
2. That the dates of the Planning and Zoning Commission of the City of Braidwood in 2020 shall be held at Braidwood City Hall, 141 W. Main Street, Braidwood, IL 60408 on the first Monday of the month at 7:00 pm unless otherwise noted.
3. That the schedule of the Holiday Observances of the City of Braidwood in 2020 shall be as follows:

New Year’s Day	Wednesday, January 1
Good Friday	Friday, April 10
Memorial Day	Monday, May 25
Independence Day	Saturday, July 4 (observed Friday, July 3)
Labor Day	Monday, September 7
Thanksgiving Day	Thursday, November 26

Day After Thanksgiving	Friday, November 27
Christmas Eve	Thursday, December 24
Christmas Day	Friday, December 25

4. That City Council and Plan Commission will meet at the time and on the date depicted on the list attached as Exhibit A.
5. That the City Clerk is hereby directed to post a copy of this Ordinance on the bulletin board at the Braidwood City Hall immediately upon the passage of the said Ordinance.
6. That the City Clerk is hereby directed to supply a copy of this Ordinance to any news medium that have filed an annual request for such notices.

SECTION 2. SEVERABILITY

If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect

SECTION 3. REPEALER

Any policy, resolution, or ordinance that conflicts with the provisions of this ordinance shall be and is hereby repealed to the extent of such conflict.

SECTION 4. EFFECTIVE DATE

This ordinance shall be in full force and effect from and after its passage, approval, publication, and filing with the City Clerk as provided by law.
